Explanation of Responses:

- Each share of Class B Common Stock is convertible into one share of Class A Common Stock at the option of the holder and has no expiration date.
- The reported shares were sold to satisfy the reporting person's tax obligations in connection with the vesting of restricted stock units, or RSUs.
- The price reported in Column 4 is a weighted average price. These shares were sold in multiple transactions at prices ranging from \$48.00 to \$48.18, inclusive. The reporting person undertakes to provide to the Issuer, any security holder of the Issuer, or the staff of the Securities and Exchange Commission, upon request, full information regarding the number of shares sold at each separate price.
- Each RSU represents a contingent right to receive one share of Issuer Class B Common Stock.
- The RSUs vested as to 25% on January 31, 2022 and the remaining shares vest in twelve equal quarterly installments beginning on March 20, 2022.
- Each restricted stock unit, or RSU, represents a contingent right to receive one share of Issuer Class A Common Stock.
- The RSUs vest in sixteen equal quarterly installments beginning on June 20, 2022.
- The remaining RSUs vest in eleven equal quarterly installments beginning on June 20, 2022.
- The RSUs vest in seven equal quarterly installments beginning on June 20, 2022.

10. The reported shares were withheld to satisfy the reporting person's tax liability in connection with the vesting of RSUs.

11. The shares are held of record by a family trust for which the reporting person serves as a trustee..

12. The shares are held of record by the Emerald GST Non-Exempt Trust.

13. The shares are held of record by the Sapphire GST Non-Exempt Trust.

14. The shares are held of record by an additional family trust.
